## Come to the Consensus Meeting for the LWVMA Reparations Study for Black Americans

The League of Women Voters of Arlington has scheduled its consensus meeting for the LWVMA Reparations Study: it will be **Sunday, February 9**, at 2 p.m., via Zoom. Please register in advance using the following link:

You may find it convenient to print them out before the meeting or consult them online. The background for the study follows.

At the 2023 League of Women Voters of Massachusetts (LWVMA) Convention, the LWV Amherst proposed a study of reparations to determine whether the LWVMA should adopt, by consensus, a position on reparations. Delegates voted by a wide margin to form a study committee. The proposal was set against a background of a number of recent and on-going reparations efforts, including but not limited to:

- The town of Amherst, MA, created a reparation fund, and assigned creating a plan to its African Heritage Reparations Assembly (AHRA).
- Other Massachusetts cities such as Boston and Northampton are considering studies of reparation.
- A bill proposing a commission to study reparations had been filed in the Massachusetts Senate (currently SD2393) as had a bill creating reparations for the descendants of American slavery. (SD2019).
- HR40 has been introduced at every Congressional session since 1989; in April 2021 it was for the first time moved to the House floor for full consideration, but did not receive a vote. It was reintroduced in January 2023.

The Study Committee undertook to answer the questions that are proposed in the consensus meetings. It has produced a series of documents for LWVMA members to study. There will be question-and-answer sessions with the candidates for town-wide offices: Select Board, School Committee, Board of Assessors, Housing Authority, and Town Moderator. - **Set-up/Take-down:** Help us to put up precinct signs and get other items organized for the event or take down and pack up when the event is over.

## **Membership Renewal Will Change Soon**

From the League of Women Voters of the US

LWV is switching to a new member portal for all Leagues across the country. There is no action that members need to take right now, but we want to provide you with an overview of what these changes mean for you.

In 2024, you renewed in the usual way. After the system launches in February 2025, you will receive an email to log in to the portal, but you will not be asked to renew again until a year after your most recent renewal [for the LWVA, probably in March or April]. You will be given the option to sign up to auto-renew annually, and your membership will last a year after your last renewal. Once you have access to the portal, you will be able to update your own information, including contact information.

When it comes time to renew, you will receive an email reminder. Dues will no longer be a fixed rate but will be pay-what-you-can. The recommended dues amount for all members across the country will be \$75, but members can pay any amount (min. \$20), including the current dues rate [for the LWVA, \$60].

Under the current system, LWV of Arlington pays a fixed rate per member to LWV of Massachusetts and to LWVUS. Under the new system, a percentage of dues will go to the state and national League. This means that when you renew, if you would like to make an additional contribution directly to LWV of Arlington as some members choose to do when they renew, this will need to be separate from choosing a higher dues amount. A higher dues amount benefits the League as a whole and allows us to offer the option of lower dues to increase our member base but does not exclusively support the local League.

There will still be the option to renew by check for members who don't use the internet, but members who are able to access the portal and renew that way are encouraged to do so.

Members will be able to contribute by check or cash to the LWV of Arlington only (to Ann FitzGerald, 162 Summer St., Unit 1, Arlington, MA 02474).

On a member level, we hope these changes will make managing your membership easier. On a League level, this is expected to increase membership around the country and increase our ability to empower voters and defend democracy. We will keep you informed as we have new and relevant information.

LWVMA is pleased to welcome Celia Canavan as its new Executive Director. Celia is a community organizer and policy professional who comes to LWVMA with a demonstrated background in intergovernmental affairs and a commitment to voter engagement and civic education.

Previously serving as the Director of Government Affairs for the City of Brockton, Celia worked in this capacity to streamline processes for applying for federal funding opportunities, engaged municipal offices in civic development, and co-managed the start of the Brockton High School Massachusetts School Building Authority project, the largest physical and financial school building project in the Commonwealth.

Prior to her time at the City of Brockton, Celia worked on multiple ballot campaign initiatives in Maine and in Massachusetts including the 2024 Ballot Question #4 in Massachusetts (Limited Legalization and Regulation of Certain Natural Psychedelic Substances), a Maine ballot initiative to overturn Citizens United and support campaign finance reform, and a grassroots effort to implement Universal Healthcare in Maine. A passionate advocate for social justice, she has previously testified in multiple state legislatures for tribal sovereignty, election protections, and ranked choice voting. Her previous work also includes youth voter turnout and engagement, advocating for public education funding, LGBTQIA+ rights, and racial justice.

A Brockton native, Celia attended the University of Maine at Farmington, where she studied Political Science with a minor in International and Global Studies. A founding member of the LWV Greater Brockton Unit, Celia is dedicated to uplifting the mission of LWVMA, and is excited to work with the LWVMA Board of Directors, staff, and all the local Leagues.


